2020 VAN ETTEN CLMP LAKE WATER QUALITY

SECCHI DISK CLARITY

The average of the weekly clarity measurements taken to date for 2020 averaged **6.0 feet**. The average for 2019 was **7.1 feet**. The 10-year average is **6.7 feet**. The average water temperature mid-lake was **72.5 deg. F**. The clarity and temperature measurements are taken weekly from mid-May to mid-September.

PHOSPHOROUS TESTING

The 2020 spring overturn phosphorus concentration as reported by a contract laboratory was **64 parts per billion [ppb]**. The date of Ice-out was March 30. This sample was taken on April 8. The comparable concentration in 2019 was **19 ppb**. The higher-than-normal result may be because of a lack of high winds between ice out and sampling, the early Ice-Out and a cooler than normal spring or because of the change in labs. The spring result is thought to be a good estimate of the average phosphorus concentration in the lake. The 10-year average spring concentration is **28.6 ppb**. The summer sample was taken on September 20 and sent to the same lab. The reported concentration was **49 ppb**. The comparable concentration in 2019 was **31 ppb**. The 10-year average summer concentration is **43.6 ppb**.

CHLOROPHYLL A TESTING

The results of the testing in 2020 were unsatisfactory as the laboratory was using a variation in sample handling different from the one the state laboratory uses.

PLANS FOR THIS YEAR

Although the CLMP testing sign-up is getting a late start, we have signed up for the spring phosphorus sampling which will occur within two weeks following ice-out, preferably following a wind event needed to mix the lake well.

We will also sign-up for Clarity, Chlorophyll A and Summer Phosphorus testing. Additional sampling help is needed. The once per week summer sampling starts in mid-May and runs through mid-Sept. If interested in helping, call Dan Stock at 989-739-4239.

Van Etten Dam Information & Update



The Van Etten Dam is run and maintained by the Iosco County Drain Commission. Property owners in the special assessment district of the Dam pay a special assessment on the winter tax bill every year to pay for expenses incurred for operating the Dam. The Dam is inspected by Spicer Engineer Group every three years. The next inspection of the Dam will be in 2021. Previous inspections have all been satisfactory, which is the best rating. Since the recent flooding events

our engineer has looked at the dam and does not have any concerns. Upcoming maintenance to be done on the dam include replacement of a ladder and changing the oil in all four hoists and lubricating the chains. More maintenance projected to be done next year is concrete repairs as required, caulk and inject cracks as needed, clean, prime, and paint steel components and debonded areas, and repainting elastomeric coating on Dam piers.

As for this Spring. 2021 - The water level on Lake Huron is expected to be up. Lake Huron dictates how to control the different levels that affect Van Etten lake. Our goal is to have enough water in the lake to allow fishermen to launch their boats by May 1, 2021. Fishermen will have to keep an eye on the water levels at the boat launch. This doesn't mean that Mother Nature will cooperate. We all know that the weather can have nasty effects.

Other reminders......Always watch out for the Springtime debris throughout the lake and always keep all watercraft tied to the dock. Even watercraft that are on hoists. I cannot control the water level to accommodate those who are putting in their docks or taking them out. Also, we had an extension at the dock at Ratliff Park which was installed last Summer by the township. This will help with safety and give the public a more efficient launching of their boats.

RAB (Wurtsmith Restoration Advisory Board) Update

The Air Force two interim remedial propose projects are:

- 1. A line of intersecting extraction wells parallel to F-41 with treatment to reduce the flow of PFAS to Van Etten Lake.
- 2. Additional wells with treatment at an expanded facility to reduce the flow of PFAS from the Fire Training Area to Clark's Marsh.

While both will be an improvement, it is not a final solution to the problems as not all of the PFAS will be intercepted and there remains a considerable amount of residual PFAS in Clark's Marsh itself

These projects will be discussed more fully at the April 21 Virtual RAB meeting along with information on when construction will begin.

NOW (Need Our Water) Happenings

NOW in conjunction with the National Wildlife Federation, the Michigan League of Conservation Voters and the Ecology Center hosted a virtual webinar on March 31 to discuss the Clark's Marsh plan. NOW has a technical team which includes Bob Delaney that is reviewing the Clark Marsh plan.

The Air Force is tentatively planning to release its proposed interim remediation plan for Van Etten Lake sometime around mid-April with a public meeting in late April or early May. Lake homeowners like you and me should be on the lookout and prepared to participate. We're at the Air Force's mercy as to timing and content. I'm hoping that NOW will be able to also host a webinar for that plan as well, but as noted, it's all coming down really fast. One thing I can say for certain: NOW's technical team will review.

The State of Michigan held a virtual Town Hall for PFAS at Wurtsmith on April 20, 2021.
