

NOW Happenings

Need Our Water (NOW) continues to work through the Restoration Advisory Board (RAB), with our legislators, the State of Michigan and the community in its priority to "Stop the Bleeding" of PFAS contamination from the former Wurtsmith AFB near Van Etten Lake. RAB meetings occur quarterly, and significant changes have been made to the staffing of the "site" on the part of the USAF. Previously, the site was managed by staff in the Base Realignment and Closure (BRAC) Division of the Air Force Civil Engineering Center. It has now moved to the Environmental Restoration Division which describes its purpose as follows, "The Environmental Restoration Division provides environmental cleanup support across all installations. The division offers programming and execution expertise to transform Department of the Air Force environmental challenges into operational opportunities."

In addition, we continue to advocate for solid, science-based remediation which captures the entire flow of contaminants off base property. You may have seen there are Interim Remedial Actions (the new filtration facility seen from F-41) in place to capture the groundwater flow, but we continue to be concerned about their effectiveness. We realize the cleanup of the base property will take decades, but they are legally responsible for stopping the flow off the property right now. Mark Henry continues to advise us with his expertise and observations which have proven to be invaluable for our entire community.

The east side of Van Etten Lake has been affected by the contamination also. We are reminded of this regularly by the "foam events" seen on the lake that accumulate on property on the east side of the lake.

Currently there is a "Data Gap Investigation" occurring which will include work to determine the extent of that contamination. The USAF has the legal responsibility to determine the "nature and extent of the contamination" which has yet to be defined.

The State of Michigan has released its new, 2025 Eat Safe Fish Guide. Unfortunately, the new guide includes new "Do Not Eat" health advisories for fish in Van Etten Lake. According to MDHHS that means, "No one should eat fish listed as Do Not Eat, regardless of age or health. When these fish were tested, MDHHS found very high levels of chemicals. Eating even one meal of these fish could possibly lead to health problems in the future, regardless of age or health." These fish include Bluegill, Largemouth Bass/Green Bass, Smallmouth Bass, Pumpkinseed/Sunfish. Please share this information with your family and friends. NOW is attempting to elevate this concern with our State Legislators through the Great Lakes PFAS Action Network.

According to MDHHS, "Data collection for the Oscoda Area Exposure Assessment (OAEA) ended in December 2024. We estimate that all participants will have all results for the nearly 200 chemicals we are measuring by Winter 2026. After analyzing participants' lab results and survey answers, reports will be created summarizing what we learned. These reports will be available to the public online. MDHHS's OAEA project was an investigation of exposure to certain chemicals in the blood and urine of residents of the Oscoda area, including mercury, PCBs and PFAS."

WEED COMMITTEE REPORT

The year started with a major change with Lake Pro (our lake manager) being purchased by Tigris. Tigris is a large aquatic services company with 20 locations in 15 states. This change will make a larger network of aquatic services available. Our managers did not change, Michael Smith and Cameron Smith, they did a fantastic job of meeting every survey and application date while contributing their vast knowledge to our program's success. They will continue as our managers for 2026.

Solitude Lake Management is our applicator company that did a great job of meeting our application dates. Their application equipment is state of the art not just in their precise metering capability but the ability to change from surface to underwater treatment. This allows treatment in windy poor weather where surface application could not be achieved and the treatment delayed. Delayed treatments result in more weed biomass that contribute to high phosphorous and resulting algae. Solitude will again be our applicator company in 2026 and already have the required EGLE (Michigan Department of Environment Great Lakes & Energy) permitting in place. Thank you, Solitude, for your great performance in 2025 and looking forward to 2026.

The timing of the treatments is critical to a positive outcome. Weeds are full of phosphorous and other nutrients that release those nutrients when decaying after being treated. You have all seen our lake turn into "pea soup" in late summer but not this year. The decaying weeds form a layer of muck on the bottom that encourage a type of algae called Chara that grows in that muck layer.

When the muck is disturbed by boat wake or other cause the nutrients are released, and algae blooms occur. Wakeboats operating in 'Wakeboat mode' have been documented to disturb the bottom 20 to 30 feet (depending on the boat) creating unnatural barren areas that do not support vegetation or fish. This may have occurred between Loud Island and Grass Island, a popular Wakeboat path, where entire weed beds have disappeared along with the fish.

The committee conducted a second year of testing the performance of muck reducing pellets. An average of 2.5 ft of muck was consumed by these beneficial microbes with three treatments of pellets. This heavy muck area is in the north bay that also did not experience total algae growth for the first time in my memory in decades. Committee member Adam Romatz performs the CLMP (Clear Lake Monitoring Program) testing for MSU. One of the tests is clarity and Adam reported the highest clarity ever, almost 10ft! This is just another benefit from proper treatments and their timing. Decaying weeds use oxygen during the decaying process. We also had an increase in the dissolved oxygen content of our water resulting in a higher-than-normal crop of minnows.

Just a reminder that our SAD (Special Assessment District) charges you for ONLY expenses incurred. There is NO account holding collected unspent funds.

VELA and PRVEL Partnership

Beginning In 1997, the Van Etten Lake Association (VELA) was encouraged by Richard Shoemaker of the then Michigan Department of Environmental Quality (DEQ) for VELA to create an organization to seek a grant to better understand the correlation between the quality of the water coming into Van Etten Lake from the Pine river, homeowner influences on that water, and the quality of the water as it leaves the lake (via the dam). An informal group of interested persons including Ken Ratliff, Larry Murphy, Jerry Ward and Pat Copland of VELA, Kelly Duke, USDA Natural Conservation Services, Gary Kellan, Oscoda Township and Ed Roddy, Alcona Township became founding members of the Pine River Van Etten Lake Watershed Coalition (PRVEL), which was officially formed in November, 1999 with the purpose of obtaining a grant. With the assistance of Ms Duke, an EPA 319 watershed Planning grant was applied for and approved in June, 2001 and Richard Myrick, USDA, Alcona Conservation District was hired as the Planning Project Manager later that month. The plan was completed in 2003. The main purpose of the watershed management plan was to provide for better monitoring of what was happening within the 187,000 acres making up the area feeding into the lake with the understanding that "what happens up the river directly affects the lake".

2025 Van Etten CMLP Lake Water Quality Report

2025 was a great year on Lake Van Etten and I hope everyone was able to utilize our amazing lake and the nature surrounding. The 2025 water clarity showed improvement over 2024 with a slightly increased average but more importantly a more consistent clarity throughout the season. As I was taking my last ride on the lake during the bonus summer weekend of October 4th, the water clarity continued with very small sections of algae present. We were able to stop off on grass island with our dog Quincy for one more dip in the lake where the water was very refreshing. With the final data sheets being emailed in and online data entry complete, I am eager to perform this task again in 2026. I do however see a need for some assistance in the event I am not available and would like to solicit for volunteers to the clarity program. The testing is very simple with just a Secchi disk and a clipboard and there is training materials available. Please take a moment to review the training and see if this is something that may interest you.



SECCHI DISK CLARITY

Weekly clarity sampling started in mid-May and the average of the weekly sampling readings this year is 5.7ft, which compares to an average of 5.4 in 2024 and 6.2 ft over the past 10 years. Below are graphs to demonstrate the fluctuations of depth over time in the past two years with 2025 while starting lower was more consistent with improved clarity through August. After the final SECCHI disk sample during the week of Sept 14-20 the results will be uploaded into the MiCorps Data Exchange.



PHOSPHOROUS TESTING: The results of the phosphorus sampling for this year will be available later this fall.

CHLOROPHYLL A TESTING: The results of Chlorophyll sampling for this year will be available later this fall

PLANS FOR NEXT YEAR : We will be participating in the CLMP monitoring program again next year.

RAB Report

Wurtsmith Restoration Advisory Board (RAB) meetings are generally on the second month of each quarter, on the third Wednesday of those months. The next RAB meeting is scheduled for Wednesday, 19 November 2025 starting at 5:00 PM with a poster session beginning at 4:00 PM. The in-person option will be held at the Oscoda United Methodist Church. Live streaming will be available for virtual participation. Watch the Oscoda Press for the link to the live streaming option. On Tuesday, November 18, 2025, there will be an informal Technical Meeting that is open to the public and will likely be held at the Oscoda Holiday Inn.

Construction of an interim remedial action (IRA) for the Alert Aircraft Area (AAA) groundwater has been operational since January 2025 and is intended to reduce the amount of per- and polyfluoroalkyl substances (PFAS) reaching Van Etten Lake for a portion of PFAS in that area of the base. The USAF's preferred project alternative is hydraulic control of the PFAS using pump and treat with granular activated carbon (GAC). The IRA includes a line of extraction wells that intercept part of the highest PFAS concentrations in groundwater from the AAA before they reach the lake. The extraction wells treat approximately 288,000 gallons per day which is discharged to septic system-like infiltration galleries. The treatment capacity of the pump and treat system will be 500 gallons per minute (gpm) with the room to be expanded to treat an additional 500 gpm treatment train should future expansion be required.

The AF is considering four additional IRA's for other parts of the former Air Force base that were suggested by their Critical Process Analysis team. Two of those were to be implemented in 2025, but now the Air Force has decided to delay these until 2026 - 2027. The other two IRA may be implemented in 2028 if funding is available. Part of the Three Pipes IRA is being conducted in the spring of 2026. Underground storm sewer joints that are allowing contaminated groundwater into the storm sewer system are being sealed which should prevent highly contaminated groundwater from directly discharging to the Three Pipes ditch at the sewer outfall. The majority of the Remedial Investigation work has been performed by the Air Force contractors, with the remainder of the work to be performed during the "data gap investigation" to be performed next year. The AF has established a Technical Working Group for discussing upcoming investigations, comprised of AF experts, EGLE, RAB experts, and the Oscoda Township engineer. We have had two productive meetings so far. Once the investigations have been completed, the Air Force will be selecting additional remedial actions during the Feasibility Study portion of the cleanup process. Public input will be solicited as part of the Feasibility Study process for each of the remedies that will be implemented.

Property Checks Available

Iosco County Sheriff's Department provides free security checks to homeowners who will be away from their homes for a period of time. They will periodically check the exterior of the premises. This service is offered to deter potential burglars and provides additional security while your home is unoccupied.
